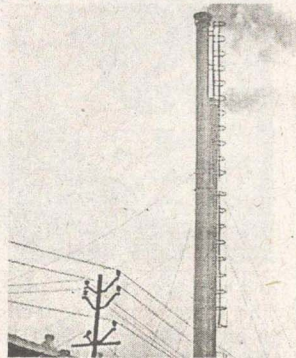

Delhi Govt plans to provide subsidy to factories for PNG switch

New Delhi/August 08

In a move that could help rid Delhi of industrial pollution, the Delhi government plans to provide subsidy to factories for switching to piped natural gas (PNG) from the fuels that are currently being used. The government's environment department has recently moved a proposal for the same before the cabinet. The subsidy amount will depend on the consumption of gas per day, government sources said. Two categories of subsidy have been proposed — Rs 1 lakh for industries consuming more than 500 units of gas and Rs 50,000 for those consuming less than 500 units. "The proposal is yet to be approved. The subsidy will provide an impetus to industries to switch over to cleaner fuels. It is intended to help clean up the air in industrial areas," an official, on condition of anonymity,



said.

Around 70% of industries in the capital's Bawana and Narela are yet to convert to PNG. The government had set a deadline of March 15 for the conversion, but it was extended to September 2018, failing which industries may face closure. According to estimates, only 513 of the 1,504 industrial units in Bawana and Narela areas have switched to piped

natural gas so far.

"The conversion is crucial for cleaning up the air around Bawana industrial area, as it was identified as one of the most polluted areas in the proximity of Delhi Technological University (DTU), that houses a number of students," the official said.

Also, the Supreme Court mandated Environment Pollution (Prevention and Control) Authority (EPCA) has asked the Delhi Pollution Control Committee (DPCC) to hold meetings with the Indraprastha Gas Limited (IGL) to follow up on the conversion in industrial areas, including those in east Delhi's Patparganj and Jhilmil. "We have asked the DPCC to issue fines to those units that still use unlisted fuels.

Goa hotel owner from Delhi killed over rented motorcycle

New Delhi: A 41-year-old native of Delhi, who ran a hotel in Goa, was murdered on Monday night following a dispute over a rented motorcycle, police said. According to police, Vishwajit Singh, who ran Hotel Royal Mirage in the coastal village of Candolim along with his brother Abhijit, was killed with knives. "From the analysis of CCTV footage and statements of the eyewitnesses, it could be ascertained that two persons were involved. The main accused was identified and eventually, his location was traced to Gadag in Karnataka," Chandan Choudhary, superintendent of police (North Goa) said. Police arrested Umesh Rathod, who was also Singh's employee for the last three years, and Dayashankar from Gadag with the help of Karnataka.
